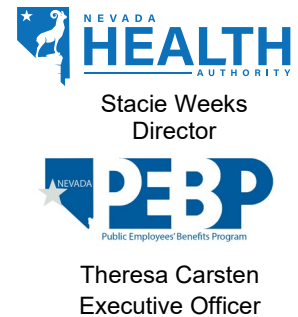

Pre-Medicare and Medicare Retirees

Dear PEBP Participant,

PEBP and Via Benefits are hosting a series of informational meetings on **October 7th and 8th** for pre-Medicare and Medicare retirees and their covered dependents. If you plan to attend, **you must register** by visiting <https://my.viabenefits.com/PEBP>. From the landing page, scroll down to the "Important Information" section. Select the date and time of the live online virtual meeting you wish to attend, then click the registration hyperlink. You will need the **GoToWebinar** software to complete the registration process. A confirmation will be sent to the email you provide, once your registration is complete. You may attend the meeting virtually, or in-person at PEBP's Carson City office in suite 117.

Pre-Medicare—Aging into Medicare Meeting:

This meeting is for participants who are currently enrolled in a PEBP self-funded plan or Health Plan of Nevada (HMO), who have not yet enrolled in Medicare and would like an overview of the transition to Medicare when they turn 65 or retire after age 65. This meeting will cover PEBP's Medicare requirements, the enrollment process, and the Exchange Health Reimbursement Arrangement (HRA) funding for eligible retirees.

Already Enrolled with Via Benefits – Medicare Open Enrollment and HRA Focused Meeting:

This meeting is for Medicare- eligible participants who are already enrolled through Via Benefits. This session will focus on Medicare open enrollment, and how to use the Exchange HRA account to help pay for out-of-pocket health care expenses and/or health care premiums and eligibility requirements.

The **Via Benefits Service Center** is available by phone to help you understand how to use your Via Benefits Exchange Health Reimbursement Arrangement (HRA). Representatives can assist you with requesting reimbursement for monthly medical, dental, prescription drug, and vision plan premiums, as well as qualified out-of-pocket medical expenses, including copays, prescription glasses, dental expenses, and Medicare Part B premiums. 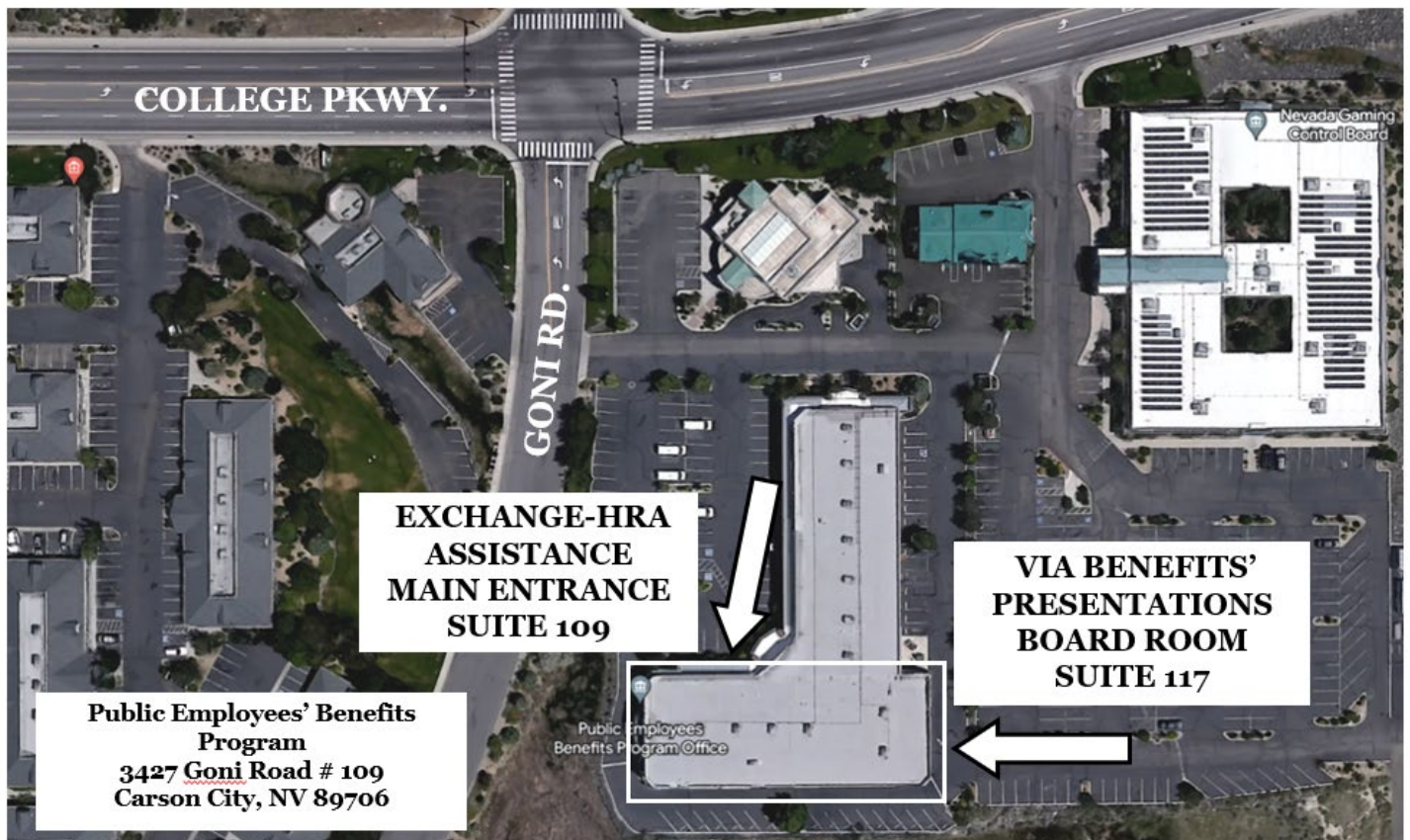
Need Additional Assistance?

If you have an issue that remains unresolved after speaking with the Via Benefits Service Center, consider scheduling an appointment with an HRA Specialist for additional assistance.

Monday, October 7th	By appointment only. Call 1-844-266-1395 to schedule an appointment with an HRA Specialist.
Tuesday, October 8th	Walk-ins are welcome. No appointment is needed to speak with an HRA Specialist; assistance will be provided on a first-come, first-served basis. Please note that waiting times may vary depending on the number of walk-ins. Hours will be from 8:00 a.m. to 4:00 p.m.
Appointments will be held separately from the presentations. Please use the main entrance at Suite #109 when checking in to see an HRA Specialist.
