Dear PEBP participant,

As tax season approaches, you will likely be gathering your tax documents to complete your return. For participants enrolled in the Health Savings Account (HSA), the 1099-SA reports distributions from your HSA account. To complete your taxes, you may need to log into your HealthSCOPE Benefits (HSB) account for January 2022 through June 2022, and your HSA Bank account for July 2022 through December 2022 to access your 1099-SA documents.

The easiest way to access this information is through your UMR account. **Not enrolled in a plan with UMR?** You may access the login pages for your HSB and HSA Bank accounts on our Plan Contacts page at [Plan Contacts \(state.nv.us\)](#).

Follow the directions below to navigate to your tax return documents.

Log into your HSB account:

1. Log into your [E-PEBP portal](#)
2. From the homepage under *My Tools*, click on the UMR single sign-on link
3. Under *myMenu* select *Account balances*, then *Health savings account (HSA)*
4. Select *View prior HealthSCOPE HSA*
 - a. Log into your HSB account
 - b. Select *Message Center* for your tax documents

HealthSCOPE will not automatically mail out this document. Participants must log into their HSB account or contact them to have the tax document(s) emailed or mailed to them. Call HSB at 888-763-8232, or email pebphsahra@healthscopebenefits.com.

Log into your HSA Bank account:

1. Log into your [E-PEBP portal](#)
2. From the homepage under *My Tools*, click on the UMR single sign-on link
3. Under *myMenu* select *Account balances*, then *Health savings account (HSA)*
4. Select *Visit HSA Bank*
 - a. Log into your HSA Bank account
 - b. Select *Message Center* for your tax documents

If participants have logged on to their HSA Bank account and set their account settings to receive paper tax documents, they will get a copy in the mail. Participants can also call in and request the tax form to be emailed or mailed directly to them. Call HSA Bank at 833-228-9364.
